Any horse or pony that comes onto HMSEA premises must be accompanied by its passport and all relevant equipment. A stable, hay/haylage (as appropriate) and staff supervision will be provided within the agreed fee. However, owners/participants are required to muck out their stable and scrub the water bucket before leaving. To help avoid equipment going missing, please ensure any kit that comes the HMSEA is clearly named/labelled.

HMSEA, the organisers, their representatives or helpers do not accept liability for injury, damage or loss suffered by spectators, participants, their horses, friends, vehicles or property, however caused, and under any circumstances, except proven negligence of the organisers. Claims for negligence against the organisers must be submitted in writing on the day of activity.

Please note – Stallions or rigs and horses/ponies under 4 years of age are not permitted on HMSEA premises.
